

ESMA Restrictions

Dear customers, the aim of this document is to introduce you the ESMA restrictions related to the Contract for differences (hereinafter " $CFD^{1"}$).

We hereby, ask you to get acquainted with this document. Thank you.

Investment service Provider² is **LYNX B.V., Branch CZ** (hereinafter "*LYNX*").; ID no.: 02451778; **Address:** Za Hanspaulkou 879/8, 160 00 Praha 6-Dejvice, Czech Republic; legal form: Branch, file no. A 76398 registered via Municipal court in Prague.

LYNX applies honest, fair and professional conduct in the provision of services in accordance with the best interests of its customers³ (hereinafter "clients"). Investor's protection and Consumer protection, incl. their interests of all clients, is our priority.

The European Securities and Markets Authority (hereinafter "ESMA") issued a statement, guidelines and FAQs related to the marketing, distributing or selling contracts for differences (CFDs)⁴ to retail clients.

Key law: Act No. 256/2004 Coll., on Capital Markets Undertakings, as amended ("ZPKT")

CFD warnings and further relevant information for the retail clients:

- <u>Public statement</u> issued 11 July 2019; ESMA adopts final product intervention measures on <u>CFDs</u> and <u>binary options</u> (available <u>here</u>); ESMA warns CFDs providers on application of product intervention measures (available <u>here</u>); ESMA's product intervention measures in relation to <u>CFDs</u> and <u>binary options</u> offered to retail investors (<u>FAQs</u>);
- ESMA's measures consist of restrictions to the: marketing, distribution or sale of CFDs to retail clients and include a.o.:
 - leverage limits on opening positions;
 - a margin close-out rule on a per account basis;
 - a negative balance protection on a per account basis;
 - preventing the use of incentives by a CFD provider; and
 - a firm specific standardized risk warning;
- When treating a retail client as a **professional client on request**, LYNX must comply with the criteria and procedures set out in Section II of Annex II of MiFID II.
- National Competent Authorities issued their own product intervention and warnings.

ESMA Restrictions

The Czech National Bank: CFD investments are inappropriate for most non-professional customers; CFD is not a standardized product, and is not suitable for "buy & hold" investments (the provision of CFDs may be linked to a possible conflict of interest; the customer is not able to check the quotes); CFDs are very risky and are not suitable for retail clients⁴. The investor's losses may exceed its initial deposit when is used leverage; In the event of a reduction margin compared to the previous valuation, the CFD provider may require immediate payment of this difference; Costs may exceed gross investment gains.

LYNX implemented procedures & policies; published info

LYNX has implemented procedures & principles mainly in "Personal Transactions Regulation"; policy contains description of mainly ethical rules and prevention of market abuse and personal trades of employees, rules for the management of conflicts of interest, rules for the provision of information to LYNX clients. Further implemented policies are e.g. "AML/CDD Policy", "Remuneration policy", "Inducement Policy", "Whistleblowing policy" etc.

Control function is also implemented e.g. Legal/Compliance function. The LYNX B.V. Group policies are implemented mandatory and staff must adhere to them. LYNX has retail, private and corporate clients. All of them have been informed about published information and documents via our webpages:

LYNX has published information related to the several offered investment products; risks are clearly described via his webpages (you can find them in the section Documents⁵).
